# 2021 BC Watershed Security Survey TOPLINE REPORT

#### **Research Methodology**

Survey results are based on an online survey of **1,012** English-speaking B.C. residents aged 18 years or older, **fielded September 17<sup>th</sup> to September 20<sup>th</sup>, 2020,** inclusive. The online survey platform was programmed for both mobile and desktop response.

Respondents for this survey were recruited using a professional online panel sample, and accurately replicate a cross-section of the B.C. population. Weighting is applied to the data according to Statistics Canada figures on economic region, age, and gender. Online panels however are not strictly a probability sample, and therefore Bayesian inference is used to estimate a credibility interval, an analogue of margin of error. The credibility interval for a total sample of n=1,012 is  $\pm 3.1\%$  at a 95% confidence level.

NOTE: All numbers in the tables that follow are percentages, unless otherwise stated. The notation \* in the following report indicates a percentage greater than zero but less than 0.05.


